

Deputy Dog Day Care SA1 ("DDDC SA1") — Day Care Liability Form. Please read the following statements carefully and confirm that you are happy and give consent by signing your name below on page 2.

- 1. I represent that I am the legal owner or agent for the owner of the dog described in the correlating application form. I will provide written consent from the true owner, if not present.
- 2. I release Deputy Dog Day Care SA1 ("DDDC SA1"), its staff, owners, representatives, and agents from all liability which I or my dog may suffer including but not limited to injury, sickness, damage, or death resulting from participation in day-care.
- 3. I represent that my dog is in good health, is current on all required vaccinations, is free of fleas, ticks, and lice, and has not been ill with any known contagious viruses in the last 30 days.
- 4. I understand that while my dog is fully vaccinated. vaccines are not guaranteed and there is a small risk that my dog may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention.
- 5. I agree to allow at least a 14-day waiting period after my dog as had their vaccinations to allow the vaccines to reach full protection potential and to ensure my dog has not has any negative reaction to the vaccines. Each vaccination has a different timescale of immunity; therefore, it is the owner's responsibility to check the correct period has elapsed before allowing them to day-care. Should I allow my dog to stay at DDDC SA1 less than 14 days after vaccination I understand that my dog could be at risk of contracting a contagious virus/disease.
- 6. I understand that although all dogs are fully supervised, incidents or injuries may occur from playing with the other dogs, which include but are not limited to bites, scrapes, scratches, and sprains.
- 7. DDDC SA1 prefer dogs in their care to be neutered and therefore at no risk of pregnancy. However, should my dog become pregnant/impregnate another day care resident, I release DDDC SA1 from any liability.
- 8. I represent that my dog is sociable and has not harmed or shown threatening behaviours towards any person or any other dog. I understand DDDC SA1 reserves the right to remove my dog from the play area and place my dog in a separate holding area should my dog display any unwanted behaviours.
- 9. I understand that DDDC SA1 reserves the right to permanently remove a dog from its day care or other facilities at any time.
- 10. I allow DDDC SA1 staff to contact my veterinarian or any other accessible vet clinic as deemed necessary should any injuries require medical attention. I agree that I am solely responsible for any medical expenses incurred for my dog.
- 11. I agree to disclose any previous or current medical issues or concerns of my dog so that DDDC SA1 staff can decide on suitability for day care.
- 12. I release DDDC SA1 from any liability should my dog injure another dog or person and accept medical and legal responsibility for my dog's actions.
- 13. I agree that my dog may be recorded on camera and its images may be used for DDDC SA1 promotional material.

- 14. I agree to pay for all outstanding charges prior to or at time of pick up of my dog.
- 15. In the event that you, your emergency contact, or any other person you have authorized to us in writing does not pick up your dog on the agreed upon departure date, you hereby authorize us to continue to provide boarding and any additional services at your expense. If such dog is deemed abandoned under UK laws DDDC SA1 will use its discretion permitted by law to following the Abandoned Pet Procedure, as outlined below.
- 16. I understand that my dogs will be boarded with dogs from other
- 17. If the dog is <u>under 6 months old</u> on their start date, the owner must acknowledge that their dog **will** be integrated with older dogs when they are confident and comfortable, but will be supervised at all times.

## ABANDONED DOG PROCEDURE:

We will attempt to contact you by telephone and/or in writing using the information that you have provided, advising that if your dog is not picked up within 48 hours, your dog will be deemed to be abandoned and we will deliver your dog to the Council appointed dog warden. The dog warden will keep the dog for 7 days before attempting to re-home the dog. If you fail to pick up your dog for any reason, you release DDDC SA1 from further liability and responsibility for your dog.

18. I agree to pick up my dog prior to closing time. Should I fail to do so, I understand that I will be charged late fees, which are in addition to the standard day care rates. I understand that dogs left after 8pm will be charged the £55 boarding fee in addition to standard rates plus any late fees incurred.

## Late Fees

• £5 for every additional 30 minutes.

## Booking/Cancellation Policy

- Full refund if cancelled 24hours before the date booked
- No refund if cancelled within 24hours of the date booked for day care (7am start).
- Make payment on booking or before collection
